Exhibitors can make checks payable to the Virginia Bar-B-Que and return with their reservation slip below. Exhibitors may begin setting up after 10:00 A.M. on Friday, June 2, 2017. Lodging is available in Beardstown and Jacksonville, Illinois.

If you are interested in reserving a spot, please fill out the slip below and return with full payment by May 24, 2017. Upon receipt of reservation and full payment, I will contact you further by mail or email about placement and any other details. If you provide an email address below, this is how I will confirm your reservation. First replies have first choice. If you are interested in the same place you had last year, please indicate this on the contract.

No pets will be allowed on the grounds, nor are any undesirable items to be sold by vendors. No silly string or items with a strong odor will be allowed. Knives are not to be uncased. If you do bring knives you must have them in a locked case and sell only to adults-many are illegal. We want this to be a safe, family-friendly festival. Also, there is NO CAMPING allowed on the square. If compliance with our requests cannot be met, you will be asked to leave.
